Note: Unsupervised break times will occur between 12-1.30pm and 5.30-7pm. During this time students may leave the theatre to spend time in the city to get dinner or lunch. Two staff members will be available for limited supervision and students will have some free time during this time. Students will travel in buddy groups. Transport: Students will make their own way to and from the Canberra Theatre. Students must be collected by a parent after the show.





Cost: \$35

**Food:** Students will need plenty of water and food/snacks for the whole day. There will be an opportunity to leave the theatre at the break times 12-1.30pm and 5.30-7pm as a group and for us to purchase dinner in Civic before returning to the theatre at 7pm.

**Clothing:** Students should be dressed in comfortable clothing and bring their costumes separately to change into before their performance. <u>Students should NOT wear their costumes throughout the day.</u>

**Note:** If you prefer your child to be collected from the theatre at Midday to return to school, you may arrange to collect them and they need to make their own way back to the theatre at 7pm for the curtain call.

During school hours, Mount Stromlo's front office can relay messages to staff and students on the excursion.

It is customary for the school to request a financial contribution towards meeting the cost of your child's participation in this excursion. The school has made every effort to keep costs for this activity at a reasonable level. We have an equity fund which can be used to provide financial assistance for students where parents are unable to meet the requested contribution. If, however, there is insufficient total funding available to meet the cost of the camp/excursion, regrettably, we may not be able to proceed

Staff accompanying students on excursions will take all reasonable care while the students are in their charge to protect them from injury and to control and supervise their behaviour and activities.

Parents should be aware that staff members are not responsible for injuries or damage to property which may occur on an excursion where, in all circumstances, staff have not been negligent.
